



# PROJECT OVERVIEW

- The *Kennedy Center Access Improvements Environmental Assessment and 4(f) Evaluation* (2003 EA) analyzed the potential impacts of alternatives for improved pedestrian, vehicle, and bicycle circulation.
- Concept level designs have been developed for pedestrian access between the Kennedy Center River Terrace and the Potomac Riverfront and were presented to the US Commission of Fine Art (CFA) and National Capital Planning Commission (NCPC) for review.
- NPS and FHWA, in conjunction with DDOT and the Kennedy Center, have initiated work on an Environmental Assessment (EA) to evaluate the impacts of these designs.
- A jurisdictional transfer of NPS land would be required for the implementation of the proposed action.

## PURPOSE:

The purpose of this action is to improve pedestrian access between the Kennedy Center River Terrace and the Potomac Riverfront in Washington, DC.

## NEED:

The action is needed because physical barriers and safety concerns currently discourage pedestrian traffic between these two resources.
