Determination of Effects

Historic Properties

- LBJ Building
- Reservation 5 and portions of Maryland Avenue and its associated vista also lie within the memorial site, while 4th and 6th Streets, and Independence Avenue, define its boundaries to the east, west and north.
- Wilbur Wright Building and Orville Wright Building
- Wilbur Cohen
- The Mall
- U.S. Botanic Garden
- Hubert Humphrey Building
- U.S. Capitol Building

Determination of Effects

Adverse effect on the LBJ Building due to

- the loss of the historic fabric of the landscaped plaza
- the alteration of key spatial relationships between the building and its site
- changes to reciprocal views between the LBJ Building and other adjacent historic properties

Determination of Effects

Adverse effect on the L'Enfant Plan due to

- the placement of the built forms of four columns and the tapestry in the northeastern corner of the site, outside of the cartway, but within the historic right-of-way.
- the closure of Maryland Avenue to vehicular traffic.

No Adverse effect on

Stipulations of the MOA

1. The final design will be compatible with the historic and architectural qualities of the LBJ Building, the L'Enfant Plan, and adjacent historic properties in and help fulfill the Design Principles. A physical representation of the historic 50-foot Maryland Avenue cartway will be incorporated into the Memorial design.

Stipulations of the MOA

2. The NPS and EMC shall include information about the history of the site in the public education materials created for the Memorial E- Memorial.

Stipulations of the MOA

3. The EMC will complete a **survey and documentation of the LBJ plaza** in accordance with the Historic American Landscapes Survey (HALS) documentation standards prior to construction of the Memorial.

Stipulations of the MOA

4. The NPS has pursued and will continue to pursue a phased approach to archeological resources, beginning with a Phase 1A study and geoarcheological consultation. The geoarchaeological investigation will include the collection and analysis of soil borings.

Stipulations of the MOA

5. Design issues that have been introduced, but not resolved, include the **scale and placement of Memorial elements, and the tapestry material and fabrication method. Before making a final decision on these issues, the NPS will consult** in accordance with this Agreement.

Stipulations of the MOA

6. The NPS will ensure that measures for the treatment of unexpected archaeological discoveries will be inserted into all contracts for ground-disturbing activity resulting from construction of the Memorial.

Stipulations of the MOA

7. The NPS will submit a copy of the final plans for the Memorial to the DC SHPO, the ACHP, and to any other signatory or consulting party which requests a copy for their records.
8. The NPS will update the public via the Planning, Environment, & Public Comment (PEPC) website on actions taken to implement the terms of this MOA.
9. The NPS will provide semi-annual status reports for the signatories and consulting parties.

Stipulations of the MOA

10. This Agreement will be valid for a period of five years from the date of the last signature. This Agreement may be amended when agreed upon in writing by all signatories. The amendment will be effective on the date of the last signature.

Stipulations of the MOA

11. If a signatory to this Agreement determines that the terms cannot be or are not being carried out, that signatory shall notify the others. If within 15 days an amendment cannot be reached, the agreement may be terminated. Then NPS must either (a) execute a new Memorandum of Agreement (b) request, take into account, and respond to the comments of the ACHP.
