


DIAGRAM B: INDEPENDENCE AVE. ALIGNMENT WITH FAA




DIAGRAM B: INDEPENDENCE AVE. ALIGNMENT WITH FAA




DIAGRAM C: 160' COMPLIANT




DIAGRAM D: 10% REDUCTION






DIAGRAM E: SINGLE EAST COLUMN




DIAGRAM F: DIAGONAL TAPESTRY




DIAGRAM G: HYBRID SCHEME
