Subject: Release of the Thomas Jefferson Memorial Vehicle Security Barrier

**Environmental Assessment** 

#### Dear Sir or Madam:

The National Park Service (NPS) announces the availability of the Environmental Assessment (EA) for public review and comment for the proposed Thomas Jefferson Memorial Vehicle Security Barrier. The project would provide a permanent vehicle security barrier to protect the Memorial and its visitors.

The EA analyzes the no action alternative along with three alternatives for construction of a vehicular barrier, each of which includes improvements to bus drop-off and loading, parking for visitors with disabilities, and a relocated concession kiosk. The difference between the action alternatives is the location of the vehicle security barrier. Under Alternative 1, the vehicle security barrier follows along East Basin Drive. Under Alternative 2, the barrier alignment meanders through the Memorial grounds to reinforce the landscape's informal quality. Alternative 3 is a simplified wall located in a concentric arc alignment around the center point of the Memorial.

Alternative 1 is the NPS Preferred Alternative, the implementation of which would result in beneficial impacts to soils, visitor use and experience, human health and safety, park operations and management, and traffic and transportation. Of all the alternatives, it has the least impact to the cultural landscape. The alternative selected in the EA will be further developed into preliminary and final designs which will be subject to additional review by the National Park Service, the District of Columbia State Historic Preservation Officer, the National Capital Planning Commission, and the Commission of Fine Arts.

The EA has been prepared in accordance with the National Environmental Policy Act (NEPA) of 1969, as amended, and implementing regulations 40 CFR Parts 1500-1508, and NPS Director's Order #12 Handbook, Conservation Planning, Environmental Impact Analysis, and Decision making (DO-12). Compliance with NHPA Section 106 of the National Historic Preservation Act of 1966 is occurring concurrent to this NEPA process.
