

PRESERVING OUR AMERICAN HERITAGE: Pennsylvania Avenue Development Corporation



PL 92-578 October 27, 1972 PADC Established

- Pennsylvania Avenue developed and used in a manner suitable to its ceremonial, physical and historic relationship to the legislative and executive branches of the Federal government and to government buildings, monuments and memorials.
- Pennsylvania Avenue Plan 1974

110 Stat – 1321 April 26, 1996 – PADC Sunset

- “Pennsylvania Avenue National Historic Park” transferred from PADC to NPS.
 - GSA responsible for buildings and commercial holdings
 - NPS responsible for parks, plazas, sidewalks, sculpture, etc.
 - NCPC responsible to ensure development conforms to 1974 plan

PL 111-11, title VII. 7116 (k) (2) Stat. 1204 March 30, 2009 – Name Change

- Revised to “Pennsylvania Avenue National Historic Site”



1974 Pennsylvania Avenue Plan: Plan Objectives to be Achieved

1. Reinforce the physical and symbolic link between the White House and the Capitol.

2. Make the Avenue function as a bridge – not a barrier – between the monumental Federal core and downtown to the north;
3. Transform the Avenue into an attractive and pleasant place for residents and visitors alike;
4. Provide a mixture of cultural and commercial activities to attract a wide variety of people and activate street life;
5. Bring people back to live along the Avenue;
6. Introduce the best contemporary architectural and planning concepts;

7. Maintain a sense of historic continuity and evolution through preservation;

8. Bring jobs, shopping and business opportunities to the Avenue;
9. Reduce hardships to existing businesses by carefully staging redevelopment;
10. Ensure equal opportunities for minority businesses and workers;
11. Enhance the City's tax base;
12. Structure an overall development program that can be implemented in a timely fashion consistent with overall market demand in the area.

PRESERVING OUR AMERICAN HERITAGE: Pennsylvania Avenue Scoping Summary



2006-2008 – Part of National Mall Plan

- Stakeholder and Public Meetings – property owners, DCOP, NCPC, GSA, NPS
- Section 106 – DCOP, Property owners, NTHP, BID, GSA, ASLA, NPS, National Coalition to Save Our Mall
- Summary of public comments – related to Newsletters 1 and 3

General comments

- **Services** (restrooms, drinking fountains, food service) – concerns about street vendors, *provide educational signs*
- **Design and Resource Protection** – unity desired, retain history, improve appearance
- **Public Safety and Access** – access important, homeless concerns, enclosed Pershing Park feels unsafe, physical obstacles
- **Identity** – lack of awareness, *needs signs*

Stakeholder comments

- **Integration desired** – with city, Federal Triangle and the National Mall
- **Transportation and Access** – integrate transportation network, *pedestrian and bicycle safety improvements*, tour bus parking, way finding signs
- **Partnerships** – collaboration encouraged

PRESERVING OUR AMERICAN HERITAGE: Pennsylvania Avenue - Change since 2008



- **Bike lanes installed in center of the Avenue**
- **Federal Triangle Heritage Trail (16 stops and brochure)**
- **Visitor facilities (food and ice skating) closed at Pershing Park**
- **Jurisdiction transfers**
 - Triangle (5th/Penn) transferred to the National Gallery of Art – January 2013
 - Ben Franklin Plaza being transferred to GSA for OPO redevelopment
- **GSA Federal Triangle Security**
 - Federal Triangle Security Report
 - Commerce Building Security EA
- **Additional sidewalk cafes**
- **OPO redevelopment; FBI relocation and potential redevelopment**
- **NPS mobile phone app for education**

PRESERVING OUR AMERICAN HERITAGE: Pennsylvania Avenue - Primary Planning Issues



- **Jurisdiction** – *does jurisdiction affect ability to meet 1974 goals?*
- **Management**
 - *can management be simplified and improved?*
 - *can commercial vibrancy be enhanced?*
- **Urban Design Character**
 - *can unified character be retained and PADC streetscape be adapted to meet today's needs?*
 - *can security requirements reinforce unified design?*
- **Inaugural Parade and other permitted activities** – *can permitting be simplified?*
- **Maintenance** – *can maintenance be improved?*
- **Cultural Resources** – *what would be the impact on historic properties and features?*

PRESERVING OUR AMERICAN HERITAGE: Pennsylvania Avenue Alternatives Summary



- No Action: continue current management
- Alt A: Emphasize historic grand character / no transfer of jurisdiction
- Alt B: Emphasize vibrant streetscape and public space / includes transfer of jurisdiction of sidewalks and other areas
- Draft Preferred Alt: Maintain PADC objectives and historic Avenue while creating vibrant streetscape and public space; includes day-to-day management by a non profit with options of retained jurisdiction or some transferred jurisdiction

PRESERVING OUR AMERICAN HERITAGE: Pennsylvania Avenue Key Issues



Complicated Jurisdiction

- NPS has jurisdiction over sidewalks, plazas and parks; affects commercial activities and permitting
- DC has jurisdiction over road or carriageway
- GSA jurisdiction fronts Avenue; buildings primarily south of avenue, plus FBI to north; increasingly mixed use federal and commercial
- Recent changes in jurisdiction
 - National Gallery of Art – 5th and Pennsylvania (January 2013)
 - Old Post Office – Ben Franklin Plaza at 11-12th and Pennsylvania (underway)

Alternatives related to Jurisdiction

Jurisdiction

Objective: Simplify complicated jurisdictional issues so Avenue is bridge not barrier and can achieve PADC objectives



Portion of 1939 NCPC plan showing Pennsylvania Avenue

Alternatives – consider jurisdictional transfer

- No jurisdictional change: 2 Alts
- 2 Alts transfer jurisdiction of sidewalks and a limited number of sites to DC or others. (Alt B and Draft Preferred Alt: Option 1)
 - Transition to transfer of jurisdiction
- Option 2 Draft Preferred Alt: does not transfer jurisdiction but simplifies jurisdictional issues through management, agreements, covenants or stipulations.









PRESERVING OUR AMERICAN HERITAGE: Pennsylvania Avenue Key Issues



Complicated Management

- Commercial use and vitality not an NPS mission; some easements came with transfer
- NPS stretched thin - no site manager; facility maintenance staff also care for areas from the Mall to Columbus Plaza at Union Station
 - Deferred maintenance
- Permits – multiple permits needed from DC and NPS (construction, events, commercial)
- Presidential Inaugural Parade – 2009 bleachers and public space defined
- Overlapping law enforcement
- 1996 transfer MOA authorized working with a non-profit

Key Issue: Management Alternatives



Management

Objective: Effective management to achieve 1974 PADC Plan objectives



Alternatives*

- No Action: No management change
- Alt A: Assign NPS site manager
- Alt B: Multiple managers but more management given to DC
- Draft Preferred Alt: Day-to-day management and programming by a non-profit, such as the BID**

* GSA, NCPC and NPS responsibilities continue per 1996 MOA (update)

** Authorized use of non-profit in the 1996 MOA

PRESERVING OUR AMERICAN HERITAGE: Jurisdiction and Management Summary



No Action	No change in jurisdiction or management
Alternative A	No change in jurisdiction; NPS to assign site manager through heritage corridor program
Alternative B	Transfer sidewalks and other identified areas to DC; DC manages commercial activities and health inspections; DC and NPS both continue to independently handle event permitting, programming, maintenance, and law enforcement
Draft Preferred Alt: Option 1	Transfer sidewalks and other identified areas to DC with management by non-profit entity (simplifies management to facilitate commercial activities, events, programming, maintenance, law enforcement, and health inspections) – Requires update of 1996 MOA
Draft Preferred Alt: Option 2	NPS maintains most sidewalk jurisdiction, but simplifies management through non-profit entity – Requires update of 1996 MOA



Pennsylvania Avenue Plan

Key Issue: Commercial Vitality

Commercial Vibrancy and Activation – PADCC priority

Objective: Simplify complicated legal authorities constraining NPS management of urban environment; some easements transferred



Alternatives

- Authorize existing commercial services and use historic leasing program (No Action, Alt A, and Draft Preferred Alt Option 2)
- Seek legislation to authorize commercial use of sidewalks by adjacent businesses (Alt A Option)
- Commercial permitting through city (Alt B and Draft Preferred Alt – Option 1)



Pennsylvania Avenue Plan

Key Issue: Events and Permitting

Events and Inaugural Parade

Objective: activate Avenue by simplifying permitting and increasing flexibility



Alternatives

- Dual permitting continues (No Action and Alt A)
- Transfer most permitting to city / single permit (Alt B)
- Facilitate permitting through a non profit public private partnership as allowed in 1996 transfer legislation to provide single contact point (Preferred Alt)

Pennsylvania Avenue Plan

Key Issue: Maintenance



Improved Appearance

Objective: attractive with improved maintenance so that America's Main Street is in excellent condition



Background:

- Aging facilities not in good condition
- Deferred maintenance
- Custom elements difficult to maintain

Alternatives

- Continue to maintain; difficult to replace custom elements (No Action, Alt A)
- NPS maintains fewer sites as NPS transfers management to others (Alt B)
- Day-to-day maintenance managed through a non-profit Private Public Partnership (Preferred Alt)

PRESERVING OUR AMERICAN HERITAGE:

Key Issue: Maintaining Unified Urban Character



Monumental, grand, ceremonial avenue with unified design
PADC design philosophy - public improvements attract private development/commerce

Unified modernist PADC streetscape was not evaluated in 2007 NR because not enough time had elapsed

Unified Streetscape elements may:

- Not address current urban and residential needs – security, recycling, signs, pre-school or dog needs
- Feel dated; not meet dark skies or energy standards
- Custom elements difficult to maintain / replace

Future development can change urban character

- FBI site redevelopment offers opportunities
- Future commemorative / cultural sites identified by NCPC – Freedom Plaza; 3rd and Pennsylvania, FBI





Pennsylvania Avenue Plan

Key Issue: Unified Urban Design Character

Maintain Urban Design Character

Objective: Unified design, flexible ceremonial, commercial and daily functionality

Regardless of jurisdiction Alternatives must address new needs or obsolete elements



Common to all Alternatives

- All Alts: Update PADC square development guidelines as needed for redevelopment – GSA and NCPC
- All Alts: develop streetscape furnishings guidance within the Interagency Streetscape Manual to support precinct identity; address security and new needs; develop guidelines for commercial use; and address sustainable approaches

Key Issue: Memorials



Existing and New Memorials

Objective: Achieve NHPA/SOI Standards; visitor enjoyment of memorials



Benjamin Franklin – one of many statues that have been relocated.

Alternatives

Existing Memorials

- Retain (No Action, Alt A)
- Alt B
 - Transfer to others with covenants (Alt B)
 - Transfer but retain memorial/statue only (Alt B option)
 - Transfer but NPS maintains memorials through MOA (Alt B option)
 - Potential to move some memorials
- Preferred same as Alt B or options

New Memorials

- Accommodate 2M proposals (No Action, Alt A, B and Preferred Alt) 23

Freedom Plaza – Evolving Views

2M Goal: redesigned as nationally significant memorial

NCPC Goal: function as a civic plaza for national and DC activities



Background

- The 2001 NCPC Memorials and Museums Master Plan identified area for a nationally significant memorial
- The 2009 NCPC Monumental Core Framework Plan sees Freedom Plaza as the premier civic space for the city of Washington.

Alternatives

- NPS retains (No Action, Alt A)
 - NPS retains Freedom Plaza until future memorial approved
- Transfer Freedom Plaza to DC (Alt B, Preferred Alt Opt 1) with agreements on future commemoration
- Pulaski Statue – potentially relocate as Freedom Plaza redesigned

PRESERVING OUR AMERICAN HERITAGE:

Summary: Coordination and Working Together



- Update the 1996 Memorandum of Agreement between NPS, GSA and NCPC.
- Additional agreement needs/topics to be identified by NPS, GSA, NCPC, DC, the BID or other agencies.
- Transfer stipulations would address historic preservation, commemoration, commission review, Inaugural Parade and security requirements. (DC, NGA, NARA)
- All alternatives would include updates to Interagency Streetscape Manual.





PRESERVING OUR AMERICAN HERITAGE: Section 106 Background



- NPS has identified NR listed or eligible cultural resources.
- **PADC elements were not assessed because they were less than 50 years old**
- Resources would continue to be maintained in accordance with the NHPA, either by NPS, another federal agency or District.
- NPS doesn't anticipate impacts beyond the negligible to minor range from visitor-caused wear and tear or minor indirect visual impacts from new signage, etc.
- NPS does not anticipate adverse effects on transfer of jurisdiction with placement of covenants, etc.





