Dear Sir or Madam:

The National Park Service (NPS) is pleased to announce the release of the MD 4 at Suitland Parkway Interchange Construction Environmental Assessment (EA) for public review and comment.

The Maryland State Highway Administration (SHA) is proposing transportation improvements to the existing intersection of MD 4 and Suitland Parkway. The proposed improvements would require a transfer of National Park Service (NPS) land to SHA at the eastern terminus of the Suitland Parkway. The project area is located approximately 10 miles southeast of Washington D.C., one mile east of the Capital Beltway at the eastern terminus of the Suitland Parkway.

The purpose of this project is to facilitate transportation improvements at the intersection of MD 4 and Suitland Parkway to increase the roadway capacity to meet existing and projected travel demand along the MD 4 corridor. This action is needed because the corridor is currently experiencing excessive traffic congestion, which is projected to increase as future development brings more commuters into the area.

The EA analyzes the No Action Alternative (Alternative 1) along with two action alternatives (Alternatives 2 and 3). The selection of alternative 2 or 3 would require a permanent land transfer to facilitate the proposed transportation improvements. Alternative 2 would be a diamond-shaped roundabout interchange requiring approximately nine acres of permanent land transfer. The interchange would include two roundabouts located on Suitland Parkway at the end of the ramps from MD 4. Alternative 3, the preferred alternative, would be a signalized diamond-shaped interchange with a two-lane directional ramp from northbound MD 4 to westbound Suitland Parkway. In addition, the centerline of MD 4 would be shifted approximately 75 feet east to reduce the impacts to Suitland Parkway.

The impacts of the proposed alternatives were assessed in accordance with the National Environmental Policy Act (NEPA) and the NPS's Director's Order 12: Conservation Planning, Environmental Impact Analysis, and Decision-making, which requires that impacts to park resources be analyzed in terms of their context, duration, and intensity (NPS 2001). Several impact topics have been dismissed from further analysis because the proposed action alternatives would have resulted in negligible to no effects upon those resources. No major impacts are anticipated as a result of this project.
