
Project Background

- **The 2015 National Defense Authorization Act (Pub. L. 113-291 sec. 3901 (b)(3)(A) authorized the World War I Centennial Commission to “enhance the General Pershing Commemorative Work by constructing [on Pershing Park] appropriate sculptural and other commemorative elements, including landscaping, to further honor” American veterans of World War I**
- **World War I Centennial Commission will sponsor a national design competition for the memorial park**
- **Design will be reviewed and approved by NPS, NCPC, CFA and other relevant agencies**

Pershing Memorial

- Located in southeast corner of Pershing Park
- Contributing object to Pennsylvania Avenue National Historic Site
- 12-foot-tall bronze statue of General John Pershing
- Two perpendicular granite walls flank statue to the east and south
 - Walls are inscribed with text of Pershing commending his troops, history of American participation in WWI, and maps of the Western Front and the Meuse-Argonne Offensive

Pershing Park

- Pershing Park is a component of the Pennsylvania Avenue National Historical Site
- Pedestrian views into park blocked by landscaped berms
- Pool/ice skating rink no longer operational
- “Park with a memorial,” rather than a memorial park
- Surrounding urban context has changed (new hotels/offices, White House Visitor Center, additional hardscape/open space in Freedom Plaza)

Selected Memorial Design Goals

- Create a national WW I memorial, not an incidental memorial in a park
- Should be contemplative, not triumphal
- Should be timeless and meaningful for future generations
- Should balance a sense of enclosure and dignity with openness and visibility
- Should provide open views of the U.S. Capitol Building, respect the Pennsylvania Avenue National Historic Site, and complement adjacent sites
- Should enable universal access and require minimal maintenance



Purpose and Need

- **Purpose of the Memorial**
 - To provide a place of solemn remembrance, honor and commemoration for the more than 4 million Americans who served during World War I, both in the military and on the home front
- **Need for the Memorial**
 - To fulfill the Congressional mandate for the establishment of a World War I Memorial in Pershing Park.





What is NEPA?

National Environmental Policy Act of 1969

(NEPA; Public Law 91-190; 42 U.S.C. 4321 *et seq*)

- Established a national policy for **protecting the environment** and requires evaluation of alternative actions
- Goal: To ensure **informed decision-making**
- Can conclude with an EA and Finding of No Significant Impact (FONSI) or an EIS and Record of Decision (ROD)




What is Section 106?


Component of National Historic Preservation Act of 1966

(NHPA; Public Law 89-665; 16 U.S.C. 470 *et seq.*)

- Established a process to **protect resources** listed on, or eligible for listing on, the National Register of Historic Places, and requires the consideration of alternatives if effects on historic resources are anticipated
- Goal: To **minimize potential harm** and damage to historic properties
- Can conclude in a Determination of No Adverse Effect or a Memorandum of Agreement with Consulting Parties


