Your proposed project is an action that has been determined to result in no measurable environmental effects. It is therefore categorically excluded from further National Environmental Policy Act analysis under Categorical Exclusion: DO12 3.4 C (8) – Replacement in kind of minor structures and facilities with little or no change in location, capacity or appearance – for example, comfort stations, pit toilets, fences, kiosks, signs and campfire circles.

Posts, joists, stairs and handrails will be replaced with 4x4, 2x12 and 2x4 Douglas fir accordingly. Decking will be replaced with "in kind" materials (i.e., real wood).




