Project Background


- Congress has authorized establishment of Gold Star Mothers commemorative work in Public Law Public Law 112-239 on National Park Service land
- Work must be consistent with the Commemorative Works Act
- Process involves selecting a site and then a design for the monument
- The construction of the monument will be sponsored by the Gold Star Mothers National Monument Foundation and maintained by the NPS

Project Background (con't.)

Monument Objectives

- Express the gratitude of our nation to families who teach that military service is a worthy endeavor
- Recognize the sense of loss shared by Gold Star Mothers and Gold Star Families
- Allow Gold Star Mothers and Gold Star Families an opportunity to have a moment of reflection and contemplation

 Families to feel kinship and emotional support

Purpose of the Monument


- To honor Gold Star Mothers and Gold Star Families who have given so much to our nation
- To express the gratitude of a nation for family life that fosters caring and generous adults willing to pursue a life of service
- To commemorate the selflessness that almost inevitably occurs when Gold Star Mothers and Gold Star Families turn their grief outward into actions of kindness and concern for others
- To create an atmosphere that enables healing and wellbeing among those commemorated
- To fulfill Congressional authorization for such a monument

What is NEPA?

National Environmental Policy Act of 1969

(NEPA; Public Law 91-190; 42 U.S.C. 4321 et seq)

- Established a national policy for protecting the environment and requires evaluation of alternative actions
- **____ Goal: To ensure informed decision-making**
- Can conclude with an EA and Finding of No Significant Impact (FONSI) or an EIS and Record of Decision (ROD)




What is Section 106?


Component of National Historic Preservation Act of 1966

(NHPA; Public Law 89-665; 16 U.S.C. 470 et seq.)


- Established a process to protect resources listed on, or eligible for listing on, the National Register of Historic Places, and requires the consideration of alternatives if effects on historic resources are anticipated
- **____** Goal: To minimize potential harm and damage to historic properties
- Can conclude in a Determination of No Adverse Effect or a Memorandum of Agreement with Consulting Parties




NEPA and Section 106 – A Coordinated Approach

The NPS, in cooperation with the National Capital Planning Commission (NCPC), is evaluating an updated NEPA and Section 106 process for this memorial's site and design. The purpose of this revised process is to better align and support key decision points associated with each agency's NEPA and Section 106 responsibilities, and to ensure that the review is commensurate with the complexity of the project. In addition to this site selection scoping period, the NPS and NCPC will also conduct scoping review and a scoping meeting for design in early 2016. Following both scoping periods, an EA will be created to document potential environmental impacts. This is a deviation from NCPC's existing Environmental and Historic Preservation Procedures, which requires separate NEPA and Section 106 processes for site selection and the design of the memorial. 

Site Selection Process


- Began evaluating sites in 2013
- Developed 11 preliminary site selection criteria:
 - 1. In the District of Columbia or its environs, but not in the National Mall Reserve
 - 2. In a context meaningful to Gold Star Mothers and Gold Star Families
 - 3. Out of the overwhelming or distracting influence of other commemorative works
 - 4. Without adverse impact on other commemorative work(s)
 - 5. Without adverse impact on historic resources
 - 6. Convenient to existing tourist destinations

Site Selection Process

- Preliminary site selection criteria (con't.):

- 7. Able to accommodate groups of visitors
- 8. Able to provide a contemplative setting
- 9. Accessible by public transportation
- 10. Accessible to handicapped visitors and the elderly
- 11. Able to provide shade






