#### Archeological Investigation Programmatic Categorical Exclusion

This Categorical Exclusion (CE) will serve as a programmatic record for archeological investigations including surface survey, site documentation, and small-scale subsurface test excavations. The activities covered by this programmatic CE are those intended to obtain information regarding archeological resources for Section 110 (NHPA), research, or to inform Section 106 compliance. Investigations are often necessary to inform project scoping, as well as compliance and design efforts. These investigations will inform the design and construction of new or improved infrastructure (structures, facilities, utilities, roads), ecological restoration, and other ground-disturbing actions, which will undergo separate compliance determinations and approvals independent of this programmatic CE. The following activities are covered by this programmatic CE. Activities not listed, but similar in scope and scale, may be covered with Compliance Office approval.

- 1) Actions related to archeological l testing, as detailed in a project-specific research design or work plan developed in consultation with traditionally-associated American Indian tribes and groups and the State Historic Preservation Officer (SHPO), include the following:
- -Systematic archeological survey of the site surface, and recording surface artifacts, features, and site boundaries
- -Establishing datum points (should datum points be necessary in wilderness, the park's wilderness specialist will be consulted)
- -Collecting a sample of surface artifacts
- -Photographic documentation
- -Recording location information
- -Preparing site maps, feature maps, and sediment profiles
- -At prehistoric sites, conducting small-scale excavations that do not exceed approximately 5 percent of the estimated site volume, employing an array of techniques such as augers, shovel probes, surface scrapes, and/or excavation units up to 1 x 2 m in size.
- -At historical sites or sites with historical components, conducting excavations using similar techniques to those at prehistoric sites, but including techniques such as backhoe trenching and excavation of larger units to expose historical features
- -Screening of sediments to recover artifacts and ecofacts
- -Field documentation of artifacts left in place
- -Collecting of sediment samples
- -Preparing detailed records of excavations, included level records; auger, shovel probe, and surface scrape records; field specimen records, and daily notes
- -Cataloging and analyzing recovered cultural material

- -Preparing draft and final reports, with peer, SHPO, and tribal review, as appropriate
- -Updating standard Yosemite Archeology Office databases
- -Archiving recovered materials and project documentation in the Yosemite Museum
- 2) Actions related to field survey and archeological site recording:
- -Repeated walking in a localized area while documenting a site
- -Preparing site and feature maps, utilizing an array of equipment such as tape and compass, global positioning system, pacing, and/or range finder
- -Use of pin flags and flagging tape
- -Collecting diagnostic, at-risk artifacts, and/or other representative artifact samples
- -Establishing datum points. Typically metal tree tags affixed to trees with a nail (should datum points be necessary in wilderness, the park's wilderness specialist will be consulted)
- -Documenting cultural material, environmental variables, built environment, and major disturbances using standard Yosemite Archeology Office forms
- -Photographic documentation
- -Recording location information
- -Cataloging and analyzing recovered cultural material
- -Preparing draft and final reports, with peer, SHPO, and tribal review, as appropriate
- -Updating standard Yosemite Archeology Office databases
- -Archiving recovered materials and project documentation in the Yosemite Museum

Archeologists implementing activities covered by this programmatic CE must follow the standard operating procedures (SOPs) and mitigation measures for programmatic CEs to ensure that potential impacts are minimized and the appropriate documentation and reporting of activities occurs. Refer to the programmatic CE SOPs on Sharepoint under the Project Management/Environmental Planning and Compliance link for the most up-to-date version of the SOPs as they will be reviewed annually and updated as necessary as new mitigation measures and best practices are identified.

In addition to following the Programmatic CE SOPs and Mitigation Measures, the Project Manager must implement, in consultation with the park's subject-matter experts, mitigations specific to site investigation activities (see attached).
