



## Bridalveil Fall Rehabilitation

**Project Background** The National Park Service plans to improve visitor facilities, reduce congestion, improve visitor safety, meet accessibility standards, remove selected trees to open views, and correct long-standing maintenance issues as described in the *Bridalveil Fall Rehabilitation Environmental Assessment (EA)*. The project will implement actions prescribed in the *Merced Wild and Scenic River Comprehensive Management Plan Environmental Impact Statement (2014)*.

The environmental assessment presents a no action alternative (Alternative 1) and two action alternatives. Alternative 3 (Preferred Alternative) would provide a new accessible loop trail from the parking lot toward the existing viewing platform and replace the vault toilets at the Bridalveil Fall parking lot with flush toilets. Alternative 2, which was analyzed and not identified as the preferred alternative, would incorporate a new flush toilet at the parking lot and accessible loop trail as well as construct an additional comfort station along Bridalveil Straight and a new pedestrian bridge across Bridalveil Creek at the base of the fall.



**Issues and Concerns** Visitors to the Bridalveil Fall area frequently comment on the poorly-functioning vault toilets as well as the crowded parking area and trails. Most trails do not meet current accessibility standards.

The Bridalveil Fall Area Rehabilitation Project will:

- Improve visitor services at the base of the waterfall, including restroom facilities
- Improve accessibility for all
- Protect natural and cultural resources in the area
- Reduce crowding on the trails and the viewing platform
- Improve safety and reduce vehicular/pedestrian conflicts
- Improve interpretation and wayfinding
