


Proposed Action

The National Park Service (NPS) and District of Columbia Office of the Deputy Mayor for Planning and Economic Development are preparing an Environmental Assessment (EA) for the proposed transfer of jurisdiction of approximately 15 acres of NPS property, situated on the north side of Fort Dupont Park along Ely Place in Southeast Washington, D.C., to the DC government for recreational purposes.



The proposed recreational uses could include the addition of a new youth baseball academy and the expansion of the Fort Dupont Ice Rink. No NPS facilities or operations will be displaced as a result of this action.

The alternatives analyzed in this EA will explore new configurations of the new and existing recreational facilities and land uses on the site.

Project Purpose and Need

PURPOSE OF THE PROPOSED ACTION

The purpose of the action is to respond to the proposed transfer jurisdiction of NPS property to the District of Columbia for the improvement and expansion of sports related recreational facilities within Fort Dupont Park.

NEED FOR THE PROPOSED ACTION

The need for the proposed transfer of jurisdiction of NPS property to the District of Columbia is to facilitate the improvement and expansion of sports related recreational facilities located within Fort Dupont Park.

THE NATIONAL ENVIRONMENTAL POLICY ACT

The National Environmental Policy Act (NEPA) requires all federal agencies to consider and document the potential impacts of management actions on the human environment. The National Park Service applies NEPA in the planning process to evaluate alternative courses of action and impacts so decisions are made in accord with the conservation and preservation mandate of the NPS Organic Act of 1916.

An Environmental Assessment (EA) is a NEPA document that is prepared to assist in planning and decision-making and to determine if an action has the potential for significant impact.

Public scoping meetings are held to inform the public of the Park's proposed actions, solicit public input, and identify issues and concerns. All public input received will be considered during the environmental assessment.
