





NPS FACILIITIES KIMBALL SCHOOL RECREATIONAL FIELDS





PROJECT OVERVIEW



PURPOSE OF THE PROPOSED ACTION

The purpose of the action is to respond to the proposed transfer jurisdiction of NPS property to the District of Columbia for the improvement and expansion of sports related recreational facilities within Fort Dupont Park.

NEED FOR THE PROPOSED ACTION

The need for the proposed transfer of jurisdiction of NPS property to the District of Columbia is to facilitate the expansion of sports related recreational facilities located within Fort Dupont Park.

PROJECT OVERVIEW



- This Environmental Assessment (EA) is required under the National Environmental Policy Act (NEPA) to assist in planning and decision-making and to determine if a proposed action has the potential for significant impact.
