The proposed site is east of the prescribed fire offices, which are off Wawona District Circle on the road that ends at the wood lot. The proposed location is between two other travel trailers (see map and photos) currently parked on site and will use existing hook up for electricity. This site was used by Federal Highways for a trailer during the construction of the South Fork Bridge. The trailer would be used as an office only, needing minimal power. One to two laptops, phone and answering machine would be needed. The trailer uses propane for heat and supplies power to the refrigerator, no air conditioning is needed. Fire Management and Facilities Management staff has discussed concerns which mainly regarded power consumption impact to the current pole. PG&E has been contacted with the meter number to address any power issues. Laura Kirn and Dave Humphrey had no concerns from a cultural resource perspective regarding this placement. The trailer placement can be seasonal if there is a need for it to be moved in the fall or it could stay parked onsite over the winter. In the case of the latter, the trailer would be winterized and unused till the 2009 season, depending on the site needs.






