Looking more specifically into the Alcatraz alternatives I have some major concerns. For the Island perimeter area alternatives 1 and 3 worry me. Alternatives 1 and 3 say that they allow for trails around the perimeter to be open all times of the year for visitors, but at the same time managed to protect natural habitat values. If the visitors are allowed in any of the current closed areas during the breeding season (Feb 1 - Sept 15), the birds will choose not to breed there and there will no longer be nesting birds to be observed while they are on this trail. Overall I believe more natural resource protection, interpretation, and outreach are needed on the Island. This is an important part of Alcatraz's natural history and what Alcatraz used to be like before anything was built on the Island. It is a great opportunity for people to connect with nature up close, which doesn't happen very often these days and should be thought of as just as important as the prison and military years. Keeping the historic gardens land space to what they have now is important, the more space they are given the more habitat is taken away from the seabirds on the Island. These gardens are beautiful and the visitors enjoy them, but they can not overtake the Island because this is habitat loss for the seabirds. Also if food service is brought to the Island this will increase the amount of trash and food scraps on the Island which will foster rats and other predators which will negatively affect the seabirds. There are two things which I agree with about the other alternatives on Alcatraz. I believe the laundry building should be able to be used for events outside of the breeding season. Also I think the historic buoys in alternative three should be set out not only for historic reasons, but for resource protection and keeping boats away from the birds on the Island. I also think taking small boats from Fort Mason as getting part of the historic feel of the ferry ride as well is a great idea. Overall I believe alternative number 2 is the most important, although I realize people have differing opinions and some concepts from all alternatives will probably be implemented. I agree with some of the different ideas of alternatives 1 and 3, but I hope the committee always keeps in mind the wildlife and native habitats that our parks have and need to protect for future generations. Alcatraz Island- Alternative 2

Overview: Offering visitors more opportunities for learning about the island's natural as well as cultural history and current resources to provide a better balance between the two management mandates. Main Prison Building and adjacent areas: Maintaining natural areas and seasonal closures around the Laundry Building, Model Industries Building, Parade Ground and western side of the island, while still providing limited visitor access for wildlife viewing, research and education. Maintaining the rubble piles as important bird breeding habitat. Power Plant and Quartermaster Warehouse: We commend attempts to protect sensitive seabird areas around the Laundry Building and Model Industries building during breeding season (February - September) by excluding maintenance activities and visitor access near these structures during February- September. Island Perimeter: Positive natural resource protections proposed in Alternative 2 include the preservation and protection of natural habitat values with visitor use and access highly managed around the island perimeter (i.e., seasonal closures near seabird breeding colonies along the northeastern, south and west perimeters).

		Offshore Marine Environment: Positive natural resource protections proposed in Alternative 2 include a sensitive resource zone out to 300' off the island's western shore that would exclude boat traffic, while still allowing some boat traffic along the eastern

		Visitor Areas: We agree with the seasonal closure of the Agave Trail and Parade Ground, as presently maintained, which is an important management tactic to protect sensitive breeding bird resources, including Western and California Gulls, Brandt's Cormorants breeding on the cliffs directly below the Parade Ground, and Pigeon Guillemots nesting in crevices all along the cliffs and below the Agave Trail.

" Increased human use of the Laundry Building area would be disruptive to Western Gulls as well as Brandt's Cormorants nesting adjacent to the building. " The potential to disrupt breeding Black Oystercatchers, Pelagic Cormorants and Pigeon Guillemots along the cliffs and seawall under the Laundry Building would also be quite high (this is the only location on the island at which Pelagic Cormorants and Black Oystercatchers nest).

"A scenic corridor around the perimeter of Alcatraz would be established by Alternative 1, anticipated as a moderate to high use area. 		Alcatraz Island Alternative 2 Building and Landscape Maintenance: Proposed increased maintenance of landscapes between the Dock and the Cellhouse would: "reduce available Western Gull and Black-crowned Night-heron habitat, Since this is the most highly-trafficked visitor pathway and the bird habitat in this area has largely already been lost, this could be viewed as a mitigation for other areas now being used or proposed to be opened (such as near the Model Industries or Laundry Buildings, etc.). These other areas could remain closed and highlighted through outreach efforts as a valuable natural resource and the wild side of Alcatraz which is also an important part of the island's history. Although we commend attempts to protect sensitive seabird areas around the Laundry Building and Model Industries building during breeding season (February September), we are not sure it is realistic for the park to forego all maintenance on these structures, given its mandate to protect both natural and cultural resources. It should be feasible for maintenance to be done on these buildings and surrounding structures during the non-seabird breeding season (fall winter).

Building minor overnight accommodations within the existing structures would be preferable, but I believe that already exists with the educational overnight stays in the cells.
202	L	Thank you for the opportunity to comment on the GGNRA plans. I'd like to suggest that on Alcatraz Island, ample space should be dedicated for birds and other wildlife that need an undisturbed place to rest and nest in the bay. I believe this is listed as Alternative 2.
		ALCATRAZ ISLAND There are many problems with Alternative 1 that make it inappropriate for this or any other unit of the National Park System. The categorical denial of the natural values of the island is unacceptable. Of particular concern is that the section "Arrival Area including the entry pier and Building 64" needs a natural history element. We oppose opening closed areas to the public. This would cause irreparable environmental damage to seabirds. Building more amenities such as a hotel is completely inappropriate for Alcatraz. It is actually a contrast to the actual history of the island in which prisoners were kept in strict confinement. The idea that sensitive wildlife areas need preservation is incomplete. Cliffs are the most significant element of habitat that needs preservation and they aren't even mentioned. Management of gulls to reduce conflicts in core visitor use areas could well mean shooting or poisoning gulls. This is a terrible idea for an agency that is supposed to preserve the natural elements of our parks. Human impacts need to be controlled. We oppose the Diverse Opportunities Zone in favor of maintaining the status quo. We oppose removal of rubble from the Parade Ground and any efforts to manage bird populations to accommodate enhanced visitor access. Should the "Natural Zone" proposed in Alternative 1 be adopted it would require the destruction of significant bird habitat. Closing seabird colonies, particularly cliffs, during the nesting season only would compromise their value as roosting sites. All access points above cliff dwelling birds should be permanently closed.

		Should alternative 1 be adopted there are significant problems associated with it that must be considered. First is the matter of fresh water. It would seem the only way to provide an ample supply of fresh water for the proposed amenities would be to install a pipeline to San Francisco. While the human historical uses are emphasized these days, in our view Alcatraz's bird life ranks up with the Galapagos and as a single island probably has more diversity and populations than most of the Galapagos. Protection of its current and historic natural resources should be emphasized in all planning. Unfortunately, none of the alternatives currently described would provide adequate protection for natural resources.

The Alcatraz Island Intertribal Living Museum (AIILM). Two of the most significant legacies of the Indian Occupation of Alcatraz Island are: the acknowledgement that Native Cultures are still alive, and a sense of Hemispherical Intertribal Unity. Civic Engagement for the AIILM would be on a national and interactional level, working with Tribal Museums through out the United States, Canada and Latin America. Due to the broad geographic area the AIILM will be dealing with, operational control must remain with the Alcatraz Island curatorial staff.

Through Civic Engagement an appropriate museum location site can be determined in cooperation. The selection committee would determined if an existing building should be renovated, or start a new facility from scratch.

One recommendation is to place for the AILM on the ground level of the New Industries building that faces the Golden Gate. There are two large rooms in the New Industries building that could accommodate the AIILM. The first room should be a transition room and the second room the actual gallery area. The gallery area (interior of second room) needs to be encapsulated to provide a museum quality environment to control light, temperature and humidity. The impressive view of the Golden Gate needs to be maintained for dramatic effect, with sealed UV filtered glass and if need be inner partitions. The first room could have interpretive panels explaining the Living Indian Museum concept and program. Most importantly, the first room would be an environmental transition space. If the first room is not enough of an environmental buffer to maintain the environmental controls in the gallery room, then it is recommended that a rotating glass door be used to maintain the environmental seal in the gallery room. Another recommendation would be to refurbish what is now called the "Chapel" next to the Electric Shop. The main consideration for this building is to create a handicap access. If it is determined that a new facility is needed, a recommended site would be at the edge of the Parade Grounds facing San Francisco. Site location, size and other details would be negotiated through Civic Engagement.
