- Need to clean up old barbed wire fences, trash, etc.
- Dog walking; Coral Reef, El Granada
- Dog walking at Coral Reef Avenue, El Granada
- E. Miner, [address], Montara resident: continued ability to walk our dogs off leash in the rancho after the land is acquired.
- Leave Rancho alone-no changes required
- Maintain and enhance the natural state of the land and current uses including dog walking, hiking, equestrian, biking (no motorized)
- Please continue to allow responsible dog owners the privilege to walk their dogs
- Multi use trail to include mountain biking with single track access for all users
- My biggest concern is to maintain or expand trail system for all users including hikers, bikers and equestrians; thank you
- Most important questions: will we be working together to ensure safe and responsible bike use of off road multiuse trails? This includes single track and newly developed trails? –Matt Beytien, [email address]
- This park is 3,000 acres? You can't find 1% for people with dogs?
- Why GMP, not dog plan
- Dog walkers do have prescriptive rights in this area of Rancho C de T
- I don't want dogs on the loose running around and annoying the wildlife and people; on a leash would be fine
- I don't want to have what happened over in Marin happen in Montara—where boarding was lost to public use horses; add to it instead, add public schooling/education to educate the public correctly about horses and what real riding is. Please don't do "string" trail rides where dumb uneducated humans go on a ride and then think they know how to ride. It's not being a good steward of animals. This is my passion horseback riding and I want to carry this legacy far into the future, correctly.
- Bicycle use should not be limited to road-width trails. Single track trails are suitable for bikes and shared use.
- POST should delay transfer until dog use can be <u>assured</u>
- Off leash dog use must be maintained
- Connections from Montara Mountain to Scarper Peak and Quarry Park/Wiklow
- Be an absentee landlord. We've been doing great! We'll let you know what's broken
- Let us all keep getting along, as we have been—a diverse community living together happily
- Interview people about how they get along so well now at Rancho (Larry de Young)
- I'm concerned about "off leash" dogs that are on trail with horses. Dogs don't always obey commands and can be dangerous to horses and riders!
- Please provide buffer zone around neighbors that share the property line
- Connect trails from Montara to El Granada and Quarry Park/Wiklow
- Do clean up and develop trails to limit off-trail use
- Leaving the property as natural as possible does it need an interpretive center warming hut, etc?
- I often ride my horse with my dog following along, but have encountered packs of dogs that were not under control by "dog walker"

- What is a <u>vital</u> horse facility? What criteria did you use to determine which are vital? More specifically, are Ocean View and Ember Ridge considered vital horse facilities?
- Ray Ebersole: will be able to continue deer hunting?
- C. Fraley, Montara resident: will we be able to continue to walk our dogs off leash in the Rancho when it is converted to GGNRA ownership?
- We equestrians are appreciative of the GGNRA stated plan to preserve the stables and horse boarding facilities. These areas should be spate from public trailheads and parking lots. That way horses and dogs/bikes will be more removed from each other. Also, security of the horse boarding premises and of our horses can be maintained during 24 hours/day. Equestrian facilities should be accessible to owners only, without the public wandering through (unless the facility offers rental rail rides). Thank you.
- What is your plan for the horse facilities when private boarders leave or horses pass away? Who replaces them private owners or public use?
- With which local youth group did you meet prior to formulating this GMP?
- Please don't increase use of area around Montara
- All the groups of people have gotten along on this land for many years. How do we keep it open to all bikes, dogs, horses, kids, etc.
- Protect sensitive habitats
- In 20 or 30 years do you envision equine boarding facilities of the same size we have now?
- Did you know someone here owns the license plate "DOGTOWN"? to know that is to understand the community
- Please implement "long loop" trails as integral in CDT trail policy
- Spread users out to minimize user conflicts
- Preserve rural character
- Build trails for just hiking (not super-wide; including dog-walking)
- Allow some off leash dog use (voice control)
- We want to continue doing what we've been doing for 25 years which is walking our dogs responsibly
- To continue the current respectful on and off leash dog walking, cycling, horse riding, hiking environment
- Establishing the park = more people from metro area = sanitary facility need increase
- Plan for reforestation?
- Include a plan to buffer park from housing to prevent fire and vandalism
- Include in General Plan an acknowledgement that dog walking will be accommodated as practicable
- Everyone in Montara has 2.5 dogs; they need to be walked; this issue cannot be shunted aside; it will bite GGNRA in the behind if it isn't addressed now
- Rancho Corral de Tierra: the most important thing for me is allowing single track mountain biking trails from the top of the mountain down
- Connecting trails between Moss Beach and El Granada behind the farm bordering Hwy. 1
- Is there a POST representative in the room; what do they think of the latest alternative? And how much input do they have?
- Has any public comment or input be against allowing dogs?
- Most important issue is: keep access as current
- Making sure we have multi use trails

- Dogs on leash or under <u>true</u> voice control are no threat to horses/deer/wildcats BUT the others...!
- Stables operate at bare minimum. Prefer minimum disruption cost with maximum riparian corridor. [?] If cost goes up most equestrians can't afford it and only very wealthy remain able to board. Like what happened at Stanford.
- Retain horse <u>boarding</u>, not just trail access
- Keep the horse boarding
- Get rid of motorcycles

- My question and concern is can you allow for parking near the horse stable for hiker and bikers

- Continue off leash dog walking

- Some current problems: erosion control on steep trails, motorized vehicles using trails
- Habitat restoration is <u>vital</u> and <u>key</u> to preserving area
- Voice control dog walking has been going on in Rancho C d T for over 50 years for hundreds of people.
- National Geographic channel program called "Dog Whisperer", Caesar Milan dog trainer works with dogs with behavior problems. In almost every instance he tells owners they must exercise their dogs more and to be well socialized they have to interact off leash
- Innumerable case studies have shown that the large increase in dysfunctional canine behavior especially aggression is a direct result of more and more dogs living solitary lives
- Who will be cleaning up the horse poop on the trails? The dogs do.
