In response to requests from the public, the following two tables provide additional information regarding the correspondences received during the civic engagement comment period.

Correspondence Distribution by Code

This table provides additional information regarding the number of times a particular issue (code¹) was raised in the comment letters (correspondence²) submitted by the public during the civic engagement comment period that was open from January 18, 2022 to March 4, 2022. While the information in this table is useful in helping to identify how the correspondence was distributed across the codes, commenting is not a form of "voting" on an alternative or proposal. The number of correspondences received in support or opposition to a particular idea or concept does not make each unique idea or concept any more or less important as the NPS moves forward in the planning process.

(Note: Each correspondence may have multiple codes associated with it. As a result, the total number of correspondences in the right column is higher than the actual number of correspondences submitted by the public.)
