The National Park Service (NPS) is preparing a general management plan/development concept plan for Valles Caldera National Preserve to establish long-term direction for resource protection and visitor experiences at the park, as well as high-level concepts to guide future development and facility investments. The plan aims to establish a management vision that balances the restoration and conservation of park resources with enhanced visitor opportunities, and builds on a 2021 management zoning effort which created a strategic direction for future planning. All members of the public with an interest in, or connection to, Valles Caldera are encouraged to participate in this effort.

Located in the Jemez Mountains of north-central New Mexico, the purpose of Valles Caldera is to protect, preserve, and restore ecosystems and cultural landscapes within an outstanding example of a volcanic caldera for the purpose of education, scientific research, public enjoyment and use, and cultural continuity. The park was established as a unit of the national park system on December 19, 2014, and is known for its expansive mountain meadows, abundant wildlife, and meandering streams. The area also preserves the homeland of ancestral native peoples and embraces a rich ranching history.

The plan is in the initial stages of development, and the NPS is seeking feedback on preliminary management ideas and development concepts from May 8, 2023 to June 9, 2023. By seeking public input prior to initiating the National Environmental Policy Act process, the National Park Service can refine, improve, and/or expand the various proposed ideas that will be included in the environmental analysis.
