## Categorical Exclusion Form

**Project:** 2010-030 Yosemite Valley and Wawona DNC Roof Replacement 2010

**PEPC Project Number:** 30467

**Project Description:** The purpose of this project is to replace deteriorated roofing on various residential structures under concessioner assignment to prevent water intrusion and structural damage.

New 30-year roof coverings would be installed, as necessary. Each roof would be evaluated individually and a scope of work prepared based on the condition of each structure and its historic status.

The proposed roofs include:

- H86-H91 (six-plex), H-98, H-99, H-100, H-118: Fire-rated Cedar Shake (Valley residential unit located at Lower Tecoya Housing - Ahwahnee Meadow/Clinic Row).
- H-139: Composition Roofing (Valley residential unit located at Middle Tecoya Housing - Nob Hill).
- N-20: Architectural Shingles (Valley residential unit located behind Visitor Center).
- Novak House: Fire-rated Cedar Shake Roofing (Wawona residential unit located at the end of Spelt Road)

The roof replacement for H-100 and H-139 was completed under an official amendment to Categorical Exclusion 2008-013, but are listed above to provide complete project context.

**Scope of Work:** The National Park Service would remove all existing roof coverings, inspect and repair roof sheathing and fascias, and replace roofing in-kind. NPS would install new metal edging, flashing, and roof coverings. Shake roofs would be replaced in-kind with new fire-rated cedar shakes. Roof types listed below are subject to change pending consultation with the park historical architect to determine the appropriate in-kind materials to be used in accordance with the *Secretary of the Interior's Standards for Treatment of Historic Properties*. Upon consultation with the park historical architect, it was determined that architectural asphalt shingles are appropriate in-kind replacement materials for house N-20, as the structure is not a contributing feature to the Yosemite Valley Historic District.

Typical requirements:

- Remove all existing roof coverings to wood sheathing
- Remove all roof-edge metals
- Retain wall reglets for reuse, unless rusted throughout
- Repair rotted lumber at overhangs and porches
- Trim overhang sheathing flush with fascia
- Inspect wood skip sheathing for hidden damage, and repair as necessary
- Install new flashing at pipes

- Install new 4"x 4" drip edge
- Install roofing materials per manufacturer's specifications to ensure warranty
- Reinstall wall reglets
- Paint all flashings and reglets as needed and in consultation with the park historical architect

This project would not require a planning or design phase, as structural components would be replaced.

**Special Considerations:** Work will be scheduled during the summer when weather is favorable to re-roofing activities. Impacts to employees would be minimized as work would occur during non-quiet hours. Vehicular access to residences on Ahwahnee Row would occur on paved surfaces. Wherever feasible, small staging areas would be placed on paved roadways or patios on the west side of Ahwahnee Row.




