Categorical Exclusion Form

Project: 2009-055 Wawona Federal Highway Administration Temporary Office Trailer Placement

PEPC Project Number: 25577

Project Description: As part of the Glacier Point Road Rehabilitation and the Wawona Road Rehabilitation projects, this proposal would place a mobile trailer (60' x 8') in the Wawona maintenance area. The Federal Highway Administration (FHWA) needs a temporary (36 months) site to place their construction office trailer, while providing construction inspection and management for the above projects.

The trailer would be connected to nearby water, telephone, and power lines. Due to a PG&E transformer problem, PG&E will evaluate the need to dig a trench (estimated trench dimensions: 50 feet long by 18 inches wide by 36 inches deep) to upgrade the transformer. The trailer will be removed upon completion of the project.

Mariposa County, CA

Mitigations:

- Ensure that the park archeology office is notified for monitoring if trenching for electrical connection is necessary.

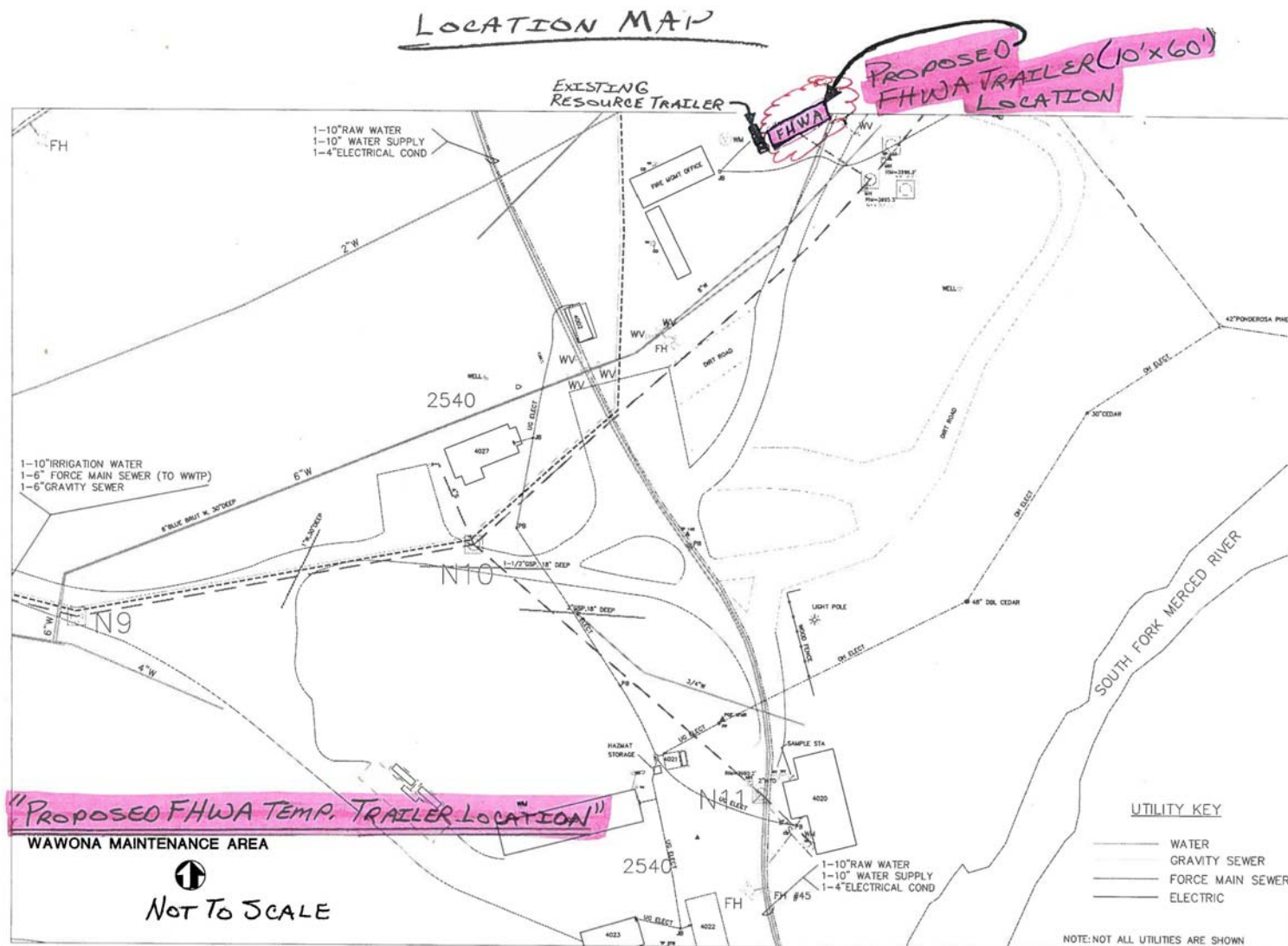
