Yosemite National Park Curry Village Rockfall Hazard Zone Structures EA Public Scoping Concern Report

Introduction

The National Park Service conducted public scoping for the Curry Village Rockfall Hazard Zone Structures project in Yosemite National Park. This project is evaluating how to address the interim disposition of structures (hard sided cabins, restrooms, shower facilities, storage units, and utilities) located within the rockfall hazard zone in Curry Village in Yosemite Valley. The recent settlement agreement on the Merced River Plan calls for any decisions about relocation and/or reuse of facilities from the rockfall hazard zone in Yosemite Valley to be postponed until a new Merced River Plan has been developed. A decision to continue to maintain facilities under this analysis does not guarantee future relocation and reuse of the structures in Yosemite Valley.

The purpose of this project is to:

- Mitigate inherent safety risks associated with unauthorized visitor access to closed structures within the rockfall hazard zone
- Minimize the potential for further loss of historically significant structures and/or features that contribute to the Curry Village historic district
- Identify appropriate mitigation to resolve the potential adverse effect on the Camp Curry Historic District

The public scoping period for this project was from February 24 to April 7, 2010. Information on the project was provided at park open houses in Yosemite Valley on February 24, 2010, and March 31, 2010. Comments were accepted through the NPS Planning, Environment, and Public Comment (PEPC) system, by mail, by fax, and comment forms submitted at the open houses.

This report summarizes the comments received from the public during the public scoping period. Information regarding how comments were compiled is followed by a summary of the comments.

Public Scoping Analysis

During the public scoping period, 33 pieces of correspondence (or letters) were received. Those correspondences received outside the PEPC system were entered by park staff in to the PEPC database (i.e., hardcopy correspondences, handwritten comment forms, emails submitted through other park communication methods). Once all the correspondence was entered into PEPC, each was reviewed and specific comments within each correspondence were identified and assigned a code that related to a particular topic to categorize similar comments together. An example of a code developed for this project is AL1500 – Alternatives: Relocate Cabins (general).

Under each code, comments were grouped by similar themes and those groups were summarized through a concern statement. For example under the code AL1500 – Alternatives: Relocate Cabins (general), one concern statement identified was, "The park should relocate the cabins instead of demolishing them."

More than half of the received comments related to alternatives to be considered. Comments on alternatives were related to a range of alternatives for removal, preservation, and relocation of the structures within the Curry Village rockfall hazard zone. Other main topics of interest were related to cultural resource issues and support for the purpose and need for the project. Of the 33 correspondences, 23 came from the state of California, while the remaining correspondences came from Arizona, Connecticut, Michigan, Oregon, or were unspecified. The large majority of correspondences (29) were from unaffiliated individuals. The remaining correspondences were from a business, tribal government, and two organizations.

This public scoping report is organized as follows:

Comments by Code: This table provides the number of comments assigned to each code.

Concerns and Comment Report: This report summarizes comments received during the scoping process by organizing the comments by codes and further into concern statements or summaries of the main ideas brought up by commenters under each code or topic. Representative quotes are then provided for each concern statement, as pulled verbatim from the correspondence text.

(USGS Open-File Report 2007-1378: Staircase Falls Rockfall on December 26, 2003 and Geologic Hazards at Curry Village, Yosemite National Park, California) Previous planning documents (even before the October '08 rockfall) have stated that "redevelopment of facilities within the common area of Curry Village (which includes Curry Pavilion, the historic visitor registration, retail facilities, and employee facilities such as housekeeping, maintenance, and employee lounge facilities) would be within the rockfall zone."

If there is a extremely large area, the cost would probably be too much. Another suggestion would be to install chain link fencing in the most dangerous areas. Many highways have this installed to keep rocks from reaching the roadway. Put the fencing in 2 or 3 areas up the hill.
